### TERMS AND CONDITIONS

1. Information on how to enter forms part of the terms and conditions of entry.
2. Incomplete or incomprehensible entries will be ineligible. Complete entries will include a first (or initial) and last name and a telephone number and/or email address at a minimum.
3. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.
4. Raffle ticket sales will commence on Wednesday 18<sup>th</sup> July, 2018 at 7:30 am and conclude on Friday 7<sup>th</sup> December 2018 at 2:00 pm local time.
5. Raffle tickets can be purchased online or face to face via paper ticketing.
6. Entrants need not be present to win. Prizes cannot be transferred or redeemed for cash.
